This amount of interest shall be remitted along with the charges due. 4. You are also requested to comply with the following: a) Hain Water conservation Regulations stipulated by CMDA should be adhered to strictly. b) 5 copies of revised plan showing the following to be furnished. 1. T.S.No.203/1 pt to be indicated in the main title of the plan. 2. Copy of the approved sub-division attested by Local Body officials to be furnished. 5.
