- Rs.3,450/- (Rs. three thousand for four hundred & fifty only)

 Rs.2,700/- (Rs. two thousand & seven hundred only)

2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered. Let it will attract interest at the rate of 12% per annum (i.e. 1% per aonth) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

- 4. You are also requested to comply with the following:
 - a) Hain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
 - b) 5 copies of revised plan delecting 'Vacant' ward in site plan and indicating 'Low Terrace' ward for porch at Terrace floor plan.

5. The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
