iv) Open Space and Reservation charges Rs. 500/- (Rs. five hundred only)

- 2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
 - 4. You are also requested to comply with the following:
 - a) Hain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
 - b) Five copies of revised plan rectifying following defects:
 1. Balcony projection in first floor not shown in GF/Stilt/

Sectional elevation has to be corrected to suit the plan.

- 3. Copy of approved sub division/Demolition plan duly attested by Local Body is not furnished.
- 4. T.S.No. 7168/1 (part) to be indicated in the title of site plan.

5. The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
