The Planning permission application/Revised
Plan received in the reference cited for the construction of Ground
Floer Residential building at P.No.14 & 15, Vigneswarar Colony,
Chennai-96 in S.No.119/3 of Okkiyam Thuraipakkam village was
examined and found approvable.

To process the application further, you are requested to remit the following charges by Three separate Demand Draft/s of a Schedule/Nationalised Bank in Chennai City drawn in favour of 'THE MEMBER-SECRETARY, CMDA, CHENNAI-8' at cash counter (between 10.00 AM and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, CMDA.

- i) Development charges for land and building: Rs. 3,000/-(Rupees three thousand only)
- ii) Scrutiny Fee : Rs. N11
- iii) Regularisation charges : Rs. 3,400/-(Rupees Three thousand four hundred only)
- iv) Open Space and Reservation charges : Rs. 88,000/-(Rupees Eighty eight thousand only)

- The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
 - 4. You are also requested to comply with the following:
- a. Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
 - b. 5 copies of revised plan rectifying the following defects to be furnished.
 - t. Compound wall details with section/elevation by showing the gate position and 7.5cm dwarf wall along with the gate to be furnished.
 - 2. S.No.11.9/3 pf.to be mentioned in the main title of the plan.
 - Outter dimension of Terrace floor plan to be indivated.
 - 4. Staircase head room size to be indicated.
- 5. The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
