To process the application further, you are requested to remit the following charges by two separate Demand Draft/s of a Schedule/Nationalised Bank in Chennai City drawn in favour of THE MEMBER-SECRETARY, CMDA, CHENNAI-8' at cash counter (between 10.00 AM and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, CMDA.

i) Development charges for land and building: Rs. 17.300/- (Rs. seventeen thousand & three hundred only)

ii) Scrutiny Fee (bal.) : Rs. 800/- (Rs. eight hundred only)

iii) Regularisation charges : Rs.

- 2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed arouth and part the cof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
  - 4. You are also requested to comply with the following:
- a. Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
  - b. 5 copies of revised plan indicating the number of W.P/
    workmen in plan.

 The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
