Sub: CMDA - Planning Permission - Construction of Stilt part + Ground Floor part +First Floor + Second Floor part Residential Building with 3 dwelling units at Plot No. 18A, Tharachend Nagar, S.No. 43, T.S.No. 17, Block No. 30 of -Wirugambakkam village - Development charges and other charges to be remitted - Reg.

The Planning Permission Application received in the reference cited for the construction of Stilt part + Ground floor part + First Floor + Second Floor part with 3 dwelling units of residential building at the above referred site at Plot No.18A, Tharachand Nagar, .No.43, T.S.No.17, Block No.30 of Virugambakkam village was examined and found approvable.

To process the application further, you are requested to remit the following separate Demand Draft/s of a Schedule/Nationalised Bank in charges by two Chennai City drawn in favour of 'THE MEMBER-SECRETARY, CMDA, CHENNAI-8' at cash counter (between 10.00 AM and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, CMDA.

- Development charges for land and building: Rs. 4, 300/- ("s. four i) thousand & three hundred only)
- : Rs. 600/- ("s. six (bal.) ' ii) Scrutiny Fee hundred only)
 - : Rs. Regularisation charges iii)
- Open Space and Reservation charges : Rs. iv)

- 2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
 - 4. You are also requested to comply with the following:
- a. Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
 - b. 5 copies of revised plan indicating T.S.No.17, Block No.30 in main title and the sub title Second Floor plan renamed as Second Floor (part).
 - c. Copy of Sub division plan approved to be attested by Local Body.

5. The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
