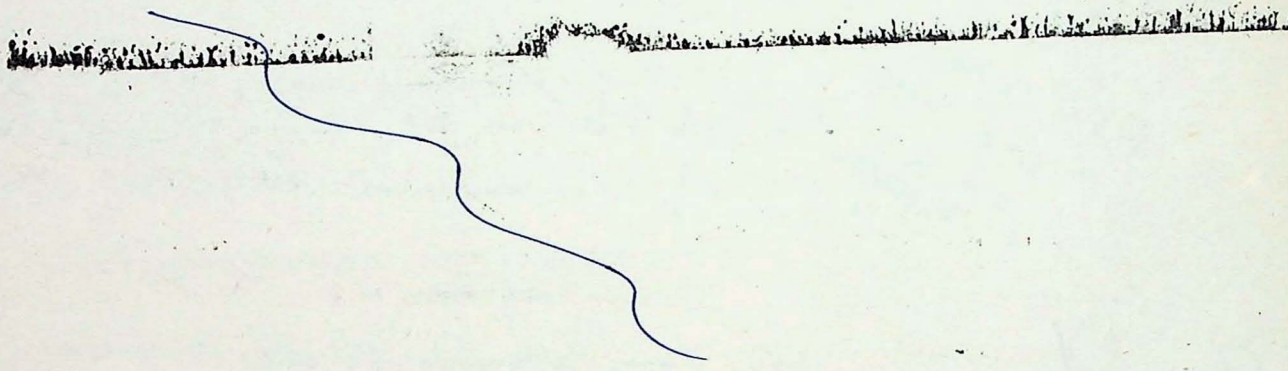


2. The Planning Permission Application would be returned unapproved, if the payment is ~~not~~ made within 30 days from the date of issue of this letter.
