- 2. The Planning Permission Application would be returned unapproved if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
  - 4. You are also requested to comply with the following:
- a. Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
  - b. Sub title of the plan tobe properly indicated.
  - c. Car parking arrangements to be shown in ground floor plan also, and
  - d. sitm out tobe renamed as balcony.
