To process the application further, you are requested to remit the following charges by a separate Demand Draft of a Scheduled/Unscheduled Bank in Chennai City drawn in favour of 'THE MEMBER-SECRETARY, CMDA, CHENNAI' or cash counter (between 10.00 AM and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plan Unit, CMDA.

- iii) Registration charges : Rs. --
- iv) Open Space and Reservation charges : Rs. --

2. The Planning Permission Application would be referred unsupervised, if the payment is not made within 30 days from the date of issue of the letter.

3. However, an specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 11% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. The amount of interest shall be remitted along with the charges due.

4. You are also requested to comply with the following:

a. Rain Water conservation Regulations stipulated by CMDA, should be adhered to strictly.

b. Five copies of revised plan indicating the following to be furnished.

1. The S.M. 115/1A/1A & part to be indicated in the main title of the plan.
2. Demolition plan/Sub division plan duly attested by the Local body to be furnished.
3. The elevation of gate it has to be shown.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments mentioned above.
