The Planning permission Application / Revised plan received in the reference cited for the construction of Stilt + Second Floor (part) with 4 dwelling units residential building at the above referred site at Plot No.3029, Door No.9, IIIrd Street, '2' Block, 13th Main Road, Anna Nagar, Chennai-40 in S.No.207(part) of Thirumangalam Village of Koyambedu Village was examined and found approvable.

2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

4. You are also requested to comply with the following:

a) Rain water conservation regulations stipulated by CMDA should be adhered to strictly.

b) A copy of the approved demolition plan sanctioned by Corporation of Chennai to be furnished.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
