The Planning Permission Application received in the reference cited for the construction of Stilt + second Floor (part) residential building with 4 dwelling units at Door No.29 and 31, Landoms Road, Kilpauk, Chennai-600 010 in R.S.No.154/87, Block No.13 of Egmore Village was examined and found approvable, as per the plans submitted by the applicant directly to this office.
