The Planning Permission Application/Revised Plan received in the reference cited for the construction of Stilt + Second Floor (part) residential building at the above referred site at D.No.29, Sivaraman Street, Chennai-5 in D.S.No.21 & 27, R.S.No.2127, Block No.38 of Triplicane village

Area Plans Unit, CMUA.

- i) Davalopment charges for land and building
- Rs.5,500/- (Rs. five thousand and five hundred only)

ii) Scrutiny Fee

- Rs. 300/- (Rs. three hundred only)
- iii) Regularisation charges
- iv) Open Space and Reservation charges



- 2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, ad additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
  - 4. You are also requested to comply with the following:
    - a. Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
    - b. 5 cepies of Revised Plan indicating 'L' type column to be shown in addition to the 'I 'Type column.

 The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
