Sub: CMDA planning permission - construction of stilt part + ground floor part + first floor + 2nd floor part with 4 dwelling units residential building at Plot No. 3. Srivalliammal Nagar S.No. 354/2 and 357/5 of Kodambakkam village approved - regarding

The planning permission application received in the reference cited for the construction of stilt part + ground floor part + first floor + 2 floors part with 4 dwelling units residential building at plot No. 3, Srivallianmal Nagar S.No. 354/2 and 357/5 of Kodambakkam village was examined and found approvable, as per the plans submitted by the applicant directly to this office.

- iii) 'To pay improvement charges, Open space Reservation charge and Other charges as applicable!
 - iv) 'Non provision of Rain Water Harvest structures as shown in the approved plan to the satisfaction of the Authority will also be considered as a deviation to approved plan and violation of DCR and Enforcement action will be taken against such development'.

iii) Regularisation charge

: Rs. 1,80,000/-(Rupees one lakh eighty thousand only)
