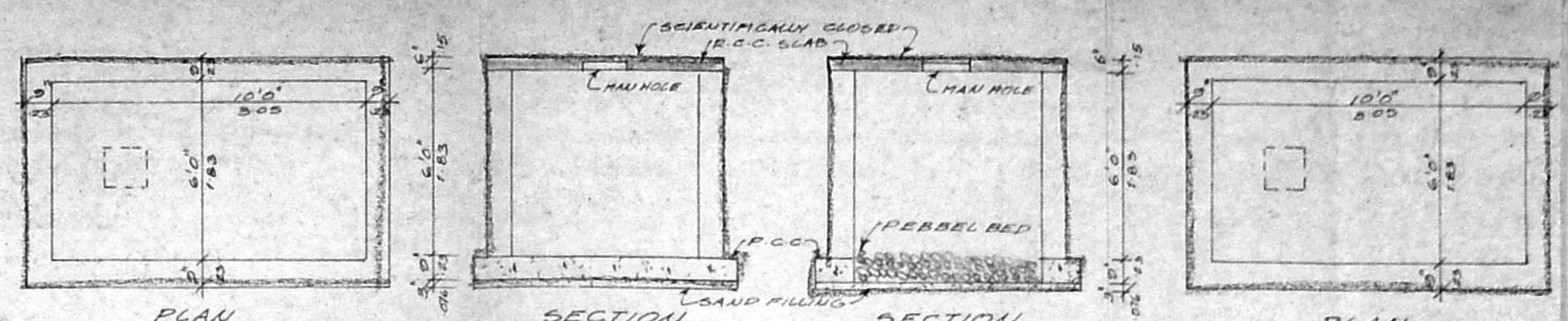

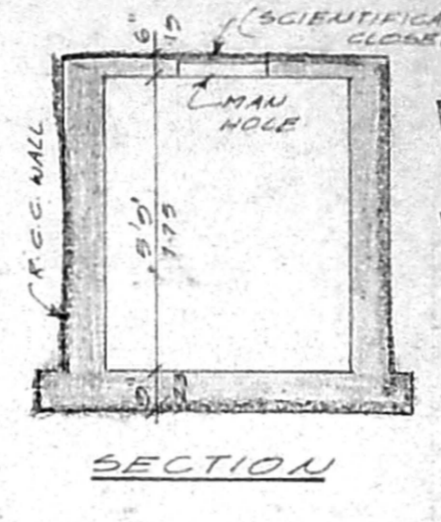
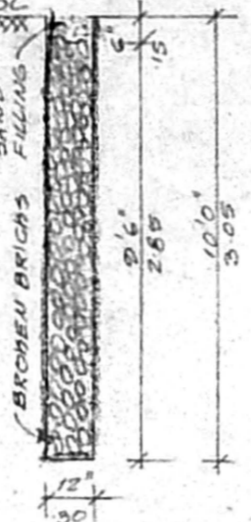

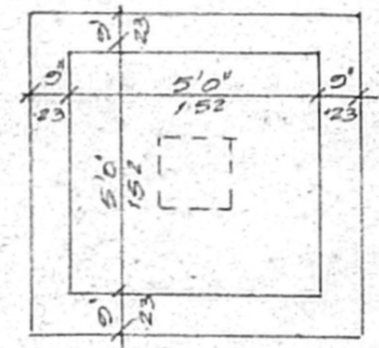
PLAN

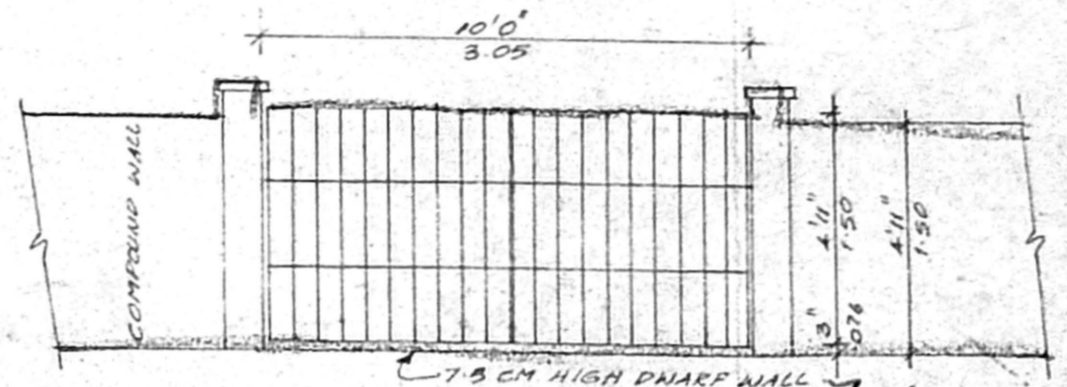

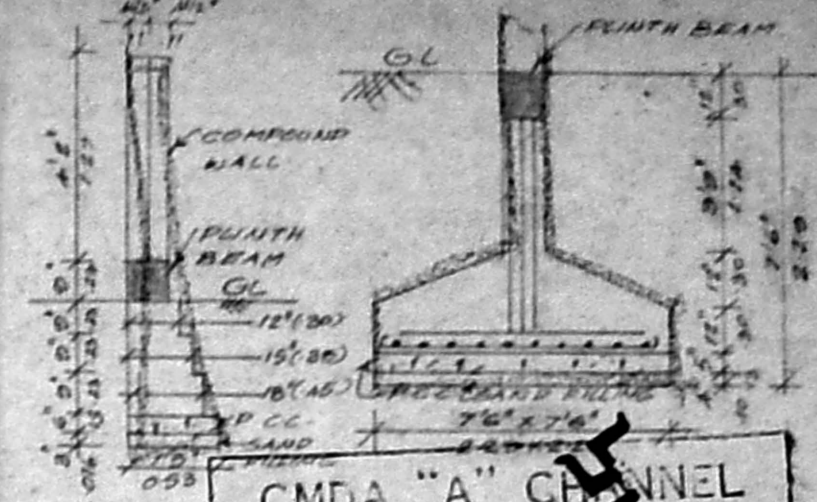
GATE DETAIL & COMPOUND WALL ELEVATION (SCALE: 1/20)



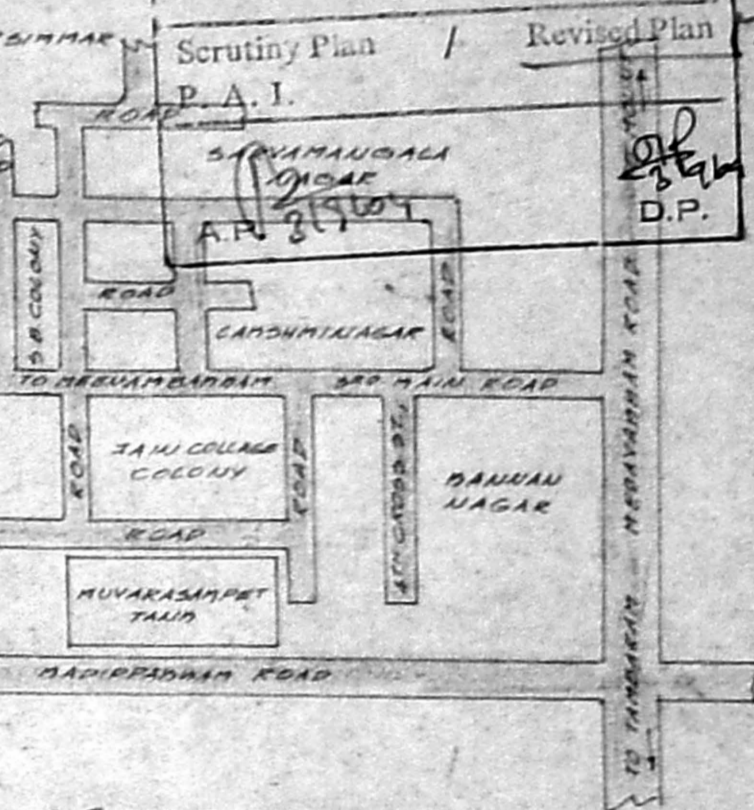

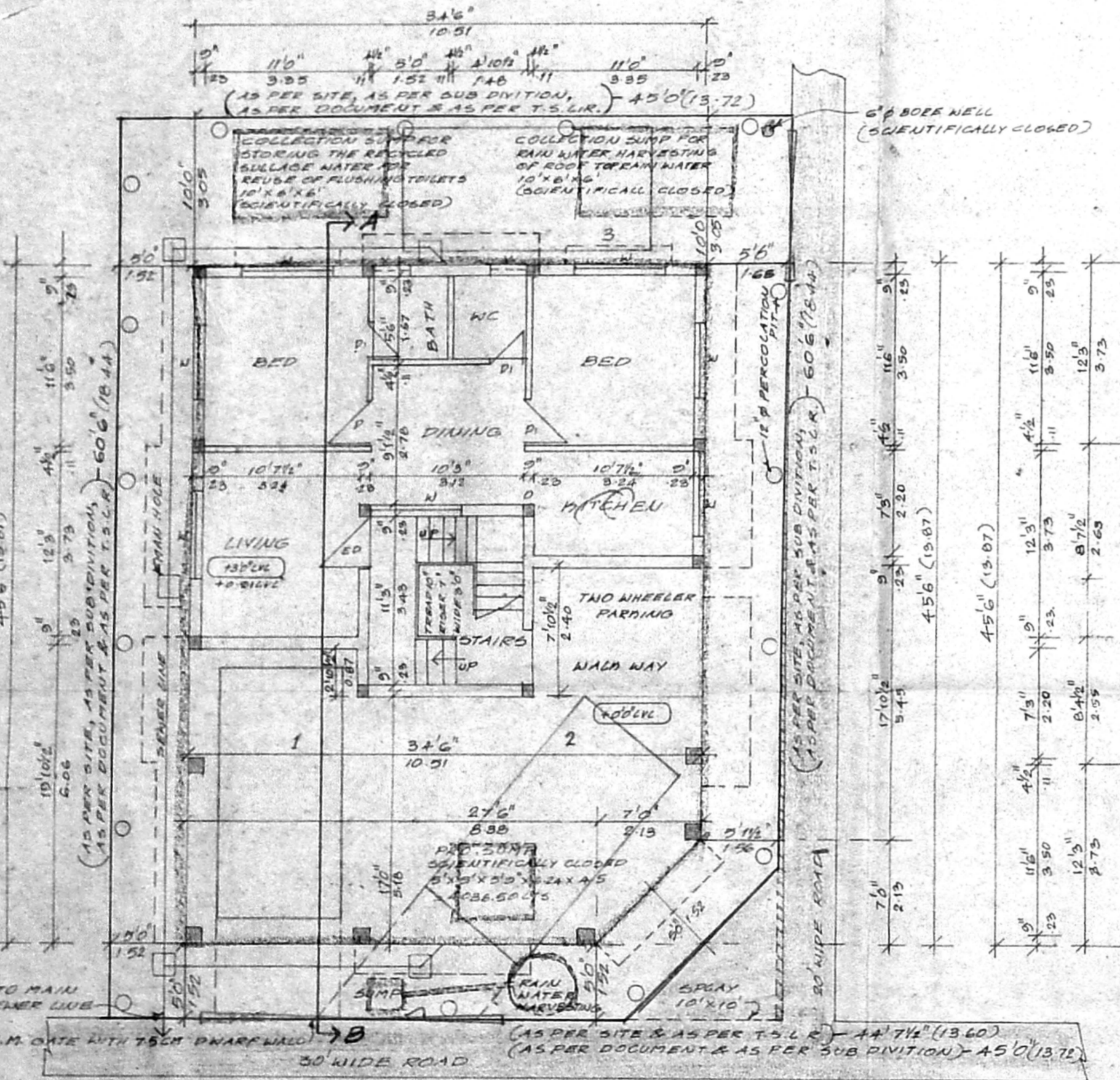

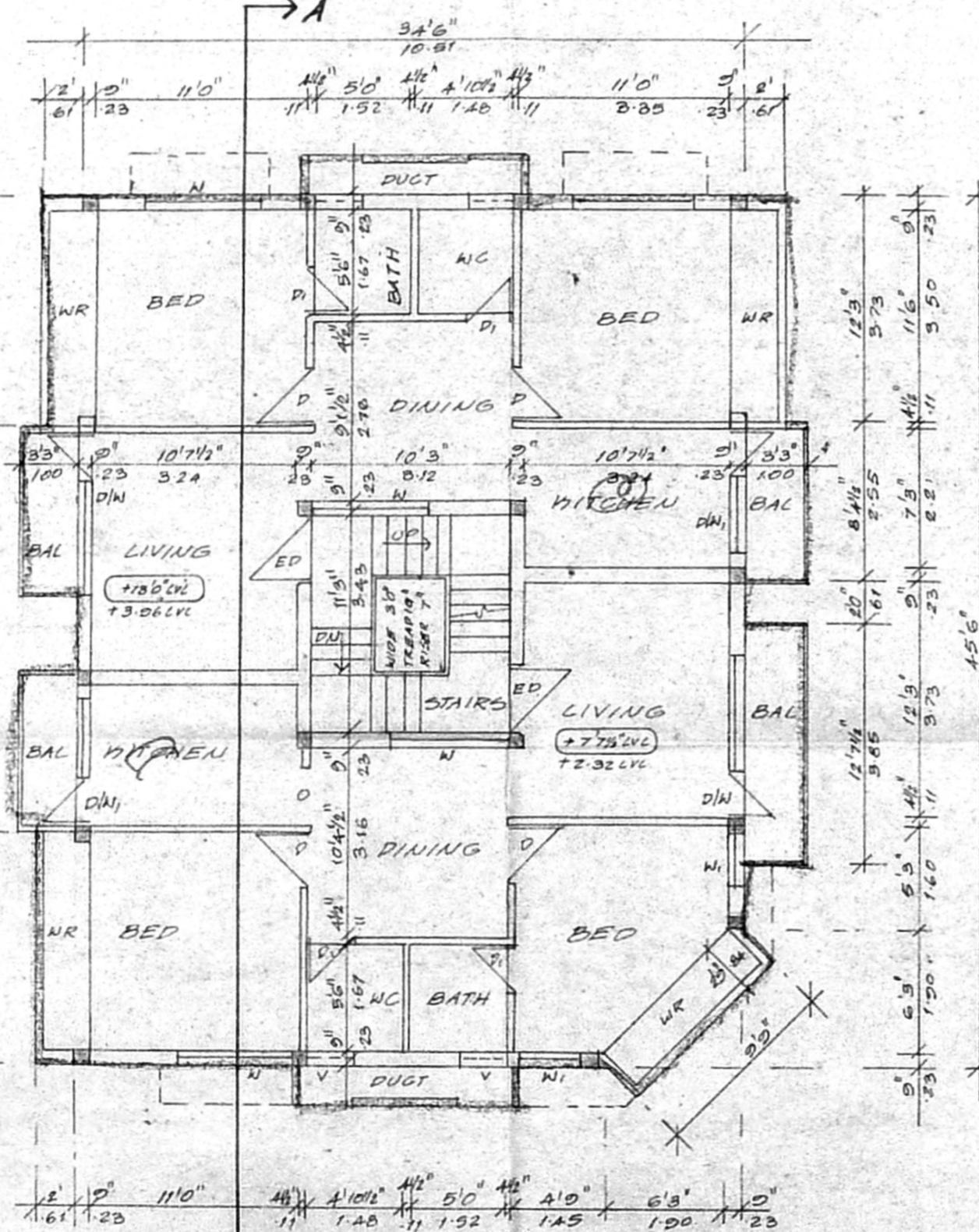
CMDA "A" CHANNEL

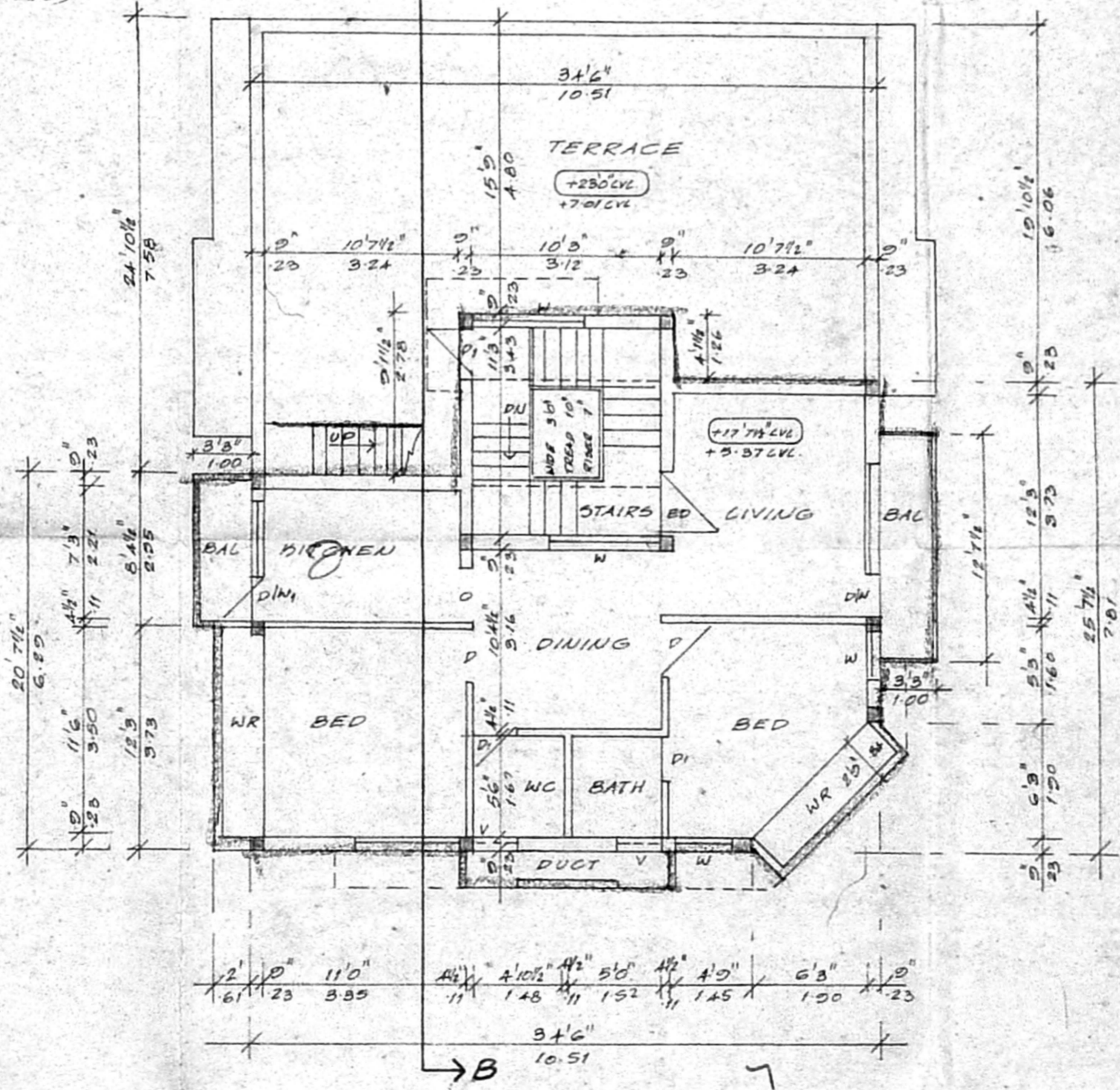
LOCATION PLAN (NOT TO SCALE)



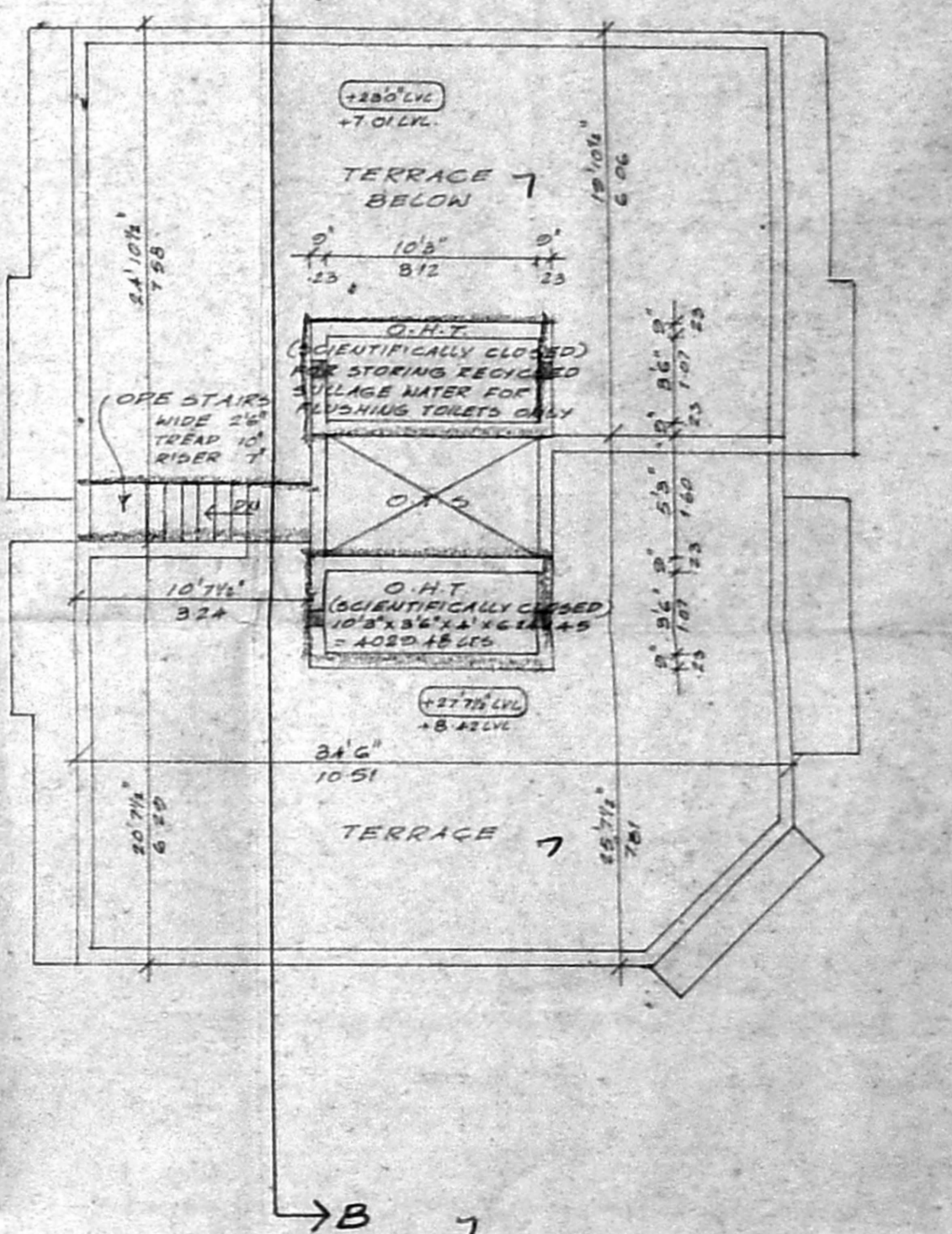
SITE CUM STILT CUM GROUND FLOOR PLAN

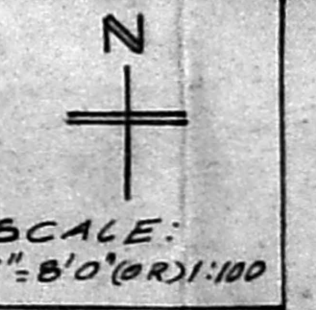
