

The Planning Permission Application received in the reference cited for the construction of Stilt part + Ground floor part + First Floor + Second floor part with two dwelling units of residential/office building at Plot No.6, T.S.D. Nagar Extn., S.No.10/2G in T.S.No.29, Block No.55 of Koyambedu village was examined and found approvable, as per the plans submitted by the applicant directly to this office.

- 2. The Planning Permission is issued subject to the following conditions:

- ii) 'To ensure that the plans for the new buildings will incorporate the approved designs for mosquito proof over had tanks and wells'.
- iii) 'To pay improvement charge and Open Space Reservation charges and other charges as applicable'.
- 'Non provision of Rain Water Harvest structures as shown in the approved plan to the satisfaction of the Authority will also be considered as a deviation to the approved plan and violation of DCR and Enforcement action wall to take against such development.
