Sub: CMDA - Planning Permission - Construction of Stilt part + Ground Floor part + First Floor + Second Floor part Residential Building with 4 dwelling unit at Plot No.102 of Kandasamy Nagar in S.No.117 of Palavakkam village - Development charges and other charges tobe remitted - Reg.

- 2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
  - 4. You are also requested to comply with the following:
- a. Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
  - b. 5 copies of revised plan showing balcony projections at terrace floor plan.
  - c. Copy of approved layout furnished to be attested by local body instead of notarised.

 The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
