The Planning Permission Application received in the reference cited for the construction of Ground Floor with one dwelling unit of Residential building at Plot No.226, s.No.3889/2, 3890, R.S.No.3889/91, Sundaram Pillai Nagar, Ist Cross Street, Block No.71 of Tondiarpet Village was examined and found approvable.

To process the applicant further, you are requested to remit the following charges by a Demand Draft of a Scheduled/Nationalised Bank in Chennai City drawn in favour of 'The Member Secretary, Chennai Metropolitan Development Authority, Chennai -600 008' at cash counter (between 10.00 A.M. and 4.00 P.M.) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, Chennai Metropolitan Development Authority.

- i) Development charges for : Rs. land and building
 - 1,600/- (Rupees One thousand and six hundred only)

ii) Scrutiny fee

: Rs.

- iii) Regularisation charges
- : Rs. 2,700/- (Rupees Two thousand and seven hundred only)
- iv) Open space reservation charges
- : Rs. 61,000/- (Rupees Sixty one thousand only)
- 2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
- 4. You are also requested to comply with the following:
 - a) Rain water conservation regulations stipulated by CMDA should be adhered to stricitly.
 - b) To furnish the copy of the approved layout duly attested by Local Body officials.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
