Sub: CMDA - Planning permission - Proposed construction of Ground floor + 3 floor residential building (reconstruction in the existing TNHB Block) with 12 dwelling units at Block No.15, Kalinga colony, P.T. Rajan Salai, K.K.Nagar, S.No.55part of Kodambakkam village, Old S.Nos.55/1A part and 56/1B part, T.S.No.2/5, Block No.98, Kodambakkam, Chennai - Approved - Regarding

The planning permission application/Revised plan received in the reference First & 2nd cited for the proposed construction of Ground floor + 3 floor residential building (reconstruction in the existing TNHB Block) with 12 dwelling units at Block No.15, Kalinga colony, P.T.Rajan Salai, K.K.Nagar, S.No.55part of Kodambakkam village, Old S.No.55/1A part and 56/1B part, T.S.No.2/5, Block No.98, Kodambakkam, Chennai has been approved subject to the conditions incorporated in the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 3rd cited and has remitted the necessary charges in challan No.34761, dated 3-8-2004 including Security Deposit for building Rs.57,000/- (Rupees Fifty seven thousand only) and Security Deposit for Display Board of Rs.10,000/- (Rupees ten thousand only) Regularisation charges of Rs.13,100/- (Rupees thirteen thousand and one hundred only) in cash.

3. a) The applicant has furnished a demand draft in favour of Managing Director, Chennai Metropolitan water supply and sewerage Board, for a sum of Rs.70,400/- (Rupees Seventy thousand and four hundred only) towards water supply and sewerage Infrastructure Improvement charges in his letter dated 20-8-2004.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after the due sanction he can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all walls, overhead tanks and septic tanks are hermetically sealed of with property protected vents to avoid mosquito menace.

4. Non provision of Rain water harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5. Two copies of approved plans numbered as planning permit No.B/spl.building/431/2004, dated 25-8-2004 are sent herewith. The planning permit is valid for the period from 25-8-2004 to 24-8-2007.

6. This approval is not final. The applicant has to approach the Chennai Corporation of issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
