


## 4. You are also requested to comply the following: .

- a) Furnish the letter of your acceptance for the following conditions stipulated by virture of provisions available Under DCR 2(b)II:
  - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
  - ii) In cases of Special Building, Group Developments, a Professionally qualified Architect Registered with council of Architects of Class -I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished.
- iii) A report in writing shall be sent to CNDA by the Architects/Class -I.Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CNDA when the building has reached upto plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.

The Licensed Survey r and Architect shall inform this Authority immediately if the contract between him/ them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- iv) The owner shall inform ChD. of any change of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CMDA that he has agreed for supervision the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period interventing between the exit of the previous Architect/Licensed Surveyor and entry of the new applicantee.
  - v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage he/she should enclose a copy of the completion certificate is obtained from CNDA.
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform CMDA of such transaction and also the make and address of the persons to whem the site is transferred immediately after such transaction and shall bind the purposed to those conditions to the planning permission.



- viii) In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible.
  - ix) If there is any false statement, suppression or any misrepresentations of acts in the applicantion, planning permission will be liable for a cancellation and the development made, if any will be treated as unnuthorised.
    - x) The new building should have mosquito proof over head tanks and wells tanks and wells.
  - xi) The sanction will be avoid abinitic, if the conditions mentioned above are not complied with.
- xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
  - a) Undertaking (in the format prescribed in Annexure -XIV to DCR) a copy of it enclosed in Rs. 10/- stamp paper duly executed by all the land owners, GPA Holders, builders and prometers separately. The undertakings shall be duly attested by a Notary Public.
  - b) Details of the ar mosed development duly filled in the format enclosed for display at the site in cases of Special Buildings and Group Developments.

5. You are als requested to furnish (a) Demand Draft drawn in favour of Monoging Dir et r, Chennai Metropolitan Water supply and Sewerage Seerd, Chemnai -2 for a sum of Rs.

The water supply and Sewerage Infrastructure improvement charge (a staturety levey) is levied under the provisions of Sec.6(xii)a of CHVSSE Amendment Act 1998 read With Sec.81(2)(jj) of the Act. As per the CHVSSE Infrastructure Development charge (lever and collection) Regulation 1998 read Development charge (levy and collection) Regulation 1998 passed in CNWSSB resolution No. 416/98, CPDA is empowered to collect the amount on behalfof CHWSSB and transfer the same to CMISSB.
