Sub: CMDA - Planning Permission - Proposed construction of Stilt Floor + 4Floor Residential building with 12 dwelling units at Plot No.49, Sringeri Mutt Road, Ramakrishna Nagar, R.S.No.3959/25, Block No.87 of Mylapore Village - Approved - Regarding.

The Planning Permission Application/Revised Plan received in the reference 1st cited for the construction of Stilt Floor + 4Floor Residential building with 12 dwelling units at Plot No.49, Sringeri Mutt Road, Ramakrishna Nagar, R.S.No. 3959/25, Block No.87 of Mylapore Village has been approved subject to the conditions incorporated in the reference.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 3rd cited and has remitted the necessary charges in Challan No.C 7252 dated.6.10.2005 including Development Charge of Rs.18,000/- (Rupees Eighteen thousand only) scrutiny Fee (Balance) of Rs.1,200/- (Rupees One thousand and two hundred only) Regularisation Charge of Rs.17,000/- (Rupees seventeen thousand only) security Deposit for proposal of Rs.69,000 (Rupees sixty nine thousand only) & Security Deposit for Display Board of Rs.10,000/- (Rupees Ten thousand only) in cash.

3. a) The applicant has furnished a demand draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs.87,000/- (Rupees Eighty seven thousand only) towards water supply and sewerage infrastructure improvement charges in his letter dated.7.10.2005.

b) with reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case, also the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all walls, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.

4) Non provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as Planning Clearance No.3/Special Building/387/2005 dated.21.10.2005 are sent herewith. The planning permit is valid for the period from 21.10.2005 to 20.10.2008.

6) This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
