- 2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 5th cited and has remitted the necessary charges in Challan No.38319 dated 23.11.2004, including D.C for land and building Rs.13,000/- (Rupees Thirteen thousand only), Balance Scrutiny Fee of Rs.500/- (Rupees Five hundred only), Security Deposit for building Rs.45,000/- (Rupees Forty five thousand only) and Security Deposit for Display Board Rs. 10,000/- (Rupces Ten Thousand only).
- 3.a) The applicant has furnished a demand draft in favour of Managing Director, CMWSSB, for a sum of Rs. 56,400/- (Rupees Fifty six thousand four hundred only) towards Water Supply and Sewerage Infrastructure Improvement charges.
- b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.
- c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for purpose of drinking and cooking
