Sub: CMDA - Planning permission - Proposed construction of Ground floor + 2 floors + 3 floors part residential building with 10 dwelling units at New No. 69, Siruvallur Main Road, Old S.No. 12,13,18/6 part, T.S.No. 18 and block No. 14 of Siruvallur village, Chennai - approved

The planning permission application/ revised plan received in the reference 1st cited for the construction of Ground floor + 2 floors + 3 floors residential building with 10 dwelling units at New No. 69, Siruvallur main Road, Old No. 12,13, 18/6 part T.S.No. 18 and Block No. 14 of Siruvallur village has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The applicant has accepted to the conditions stipulated by Chennai Metropolitan Development Authority vide in the reference 3rd cited and has remitted the necessary charges in Challan No. 35944 dated 9.9.2004 including Security Deposit for building Rs. 72,000/- (Rupees seventy two thousand only) Development charges Rs. 45,000/- (Rupees fifteen thousand only) scrutiny fee Rs. 1,000/- (Rupees one thousand only) Security Deposit for building Rs. 46,000/- (Rupees fourty six thousand only) Security Deposit for Display Board Rs. 10,000/- (Rupees ten thousand only)

3.a) The applicant has furnished a demand draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs. 58,000/- (Rupees fifty eight thousand only) towards water supply and sewerage infrastructure improvement charges in his letter dated 10.9.2004

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to metro water and only after due sanction he can commence the internal sewer works.

c) In respect of water supply, it may be possible for metro water to extend water supply to a single sump for the above premises for purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all walls, overhead tanks and septic tanks are hermetically sealed of with properly protected vents to avoid mosquito menace.

4) Non provision of rain water harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as planning permit No. B/Spl.Bldg/498 A&B/2004, are dated 13.10.2004 are sent herewith. The planning permit is valid for the period from 13.10.2004 to 12.10.2007.

6) This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposal construction can be commenced.
