- NOTE: i) Security Deposits are refundable amount without interest on claim, after issue of completion certificate by CMDA. If there is any deviation/violation/change of use of any part of white of the building/site to the approved plan Security Deposit will be forfeited.
  - ii) Security Deposit for Display Board is refundable when the Display Board as prescribed in the format is put up in the site under reference. In case of default security deposit will be forfeited and action will be taken to put up the Display Board.
  - iii) In the event of the Security Deposit is not claimed within a period of 5 years from the date of remittance, the Security Deposit shall be forfeited without any further notice.
- 2. Payments received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Deposits).
- 5. The Papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.

- ii) In cases of Special Building, Group Developments, a professionally qualified /rehitect Registered with council of Architects of Class -I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished.
- iii) A report in writing shall be sent to CMDA by the Architects/Class -I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when the building has reached upto plinth level and thereafter every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved plan.
  - The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/ them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved the
  - iv) The owner shall inform CFDA of any change of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CMDA that he has agreed for supervision the work under reference and intimate the state of construction at which he has taken over. We construction shall be carried on during the priod interventing between the exit of the previous Architect/Licensed Surveyor and entry of the new applicantee.
    - v) On completion of the construction, the applicant shall intimate CNDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CNDA.
  - vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage he/she should enclose a copy of the completion certificate is obtained from CMDA.
- vii) When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform CMDA of such transaction and also the make and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purposed to those conditions to the planning permission.

- e Open space within the site, trees should be ted and the existing trees preserved to the extent possible.
  - ix) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
    - x) The new building should have mosquito proof over head tanks and wells.
  - xi) The sanction will be avoid abinitic, if the conditions mentioned above are not complied with.
- xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
  - a) Undertaking (in the format prescribed in Annexure -XIV to DCR) a copy of it enclosed in Rs. 10/- stamp paper duly executed by all the land owners, GPA Holders, builders and prometers separately. The undertakings shall be duly attested by a Notary Public.
  - h) Details of the proposed development duly filled in the format enclosed for Display at the site in cases of Special Buildings and Group Developments.

5. You are also requested to farmish (a) Demand Draft drawn in favour of Menaging Director, Chemoi distropolitam water supply and Severage Accid, Chemoi -2 for a sum of Rs. supply and Severage don't 60.000/-

towards water supply and Severage Infrastructure improvement charges. The water supply and Severage Infrastructure improvement charge (a staturety levey) is levied under the provisions of Sec. 6(xii) a of GLISSB Americant Act 1993 read with Sec. 81(2)(jj) of the Act. 1.8 of the CMWSSB Infrastructure Development charge (levy and collection) Regulation 1290 passed in CMWSSB resolution No. 416/98, CHDA is capowered to collect the amount on behalf of CMWSSB and transfer the same to CMWSSB. 

The issue of planning permission depend on the compliance/fulfilment of the conditions/payments stated above. The acceptance by the Auth rity of the prepayment of the Development charge and Other charges etc., shall not entitle the person to the planning permission by only refund of the in case of refusal of the permission for non-compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission or any other personprivided the construction is not commented and claim for refund is made by the applicant.
