The Planning Permission Application and the Revised Plans received in the reference 1st & and cited for the construction of GF + 3 Floors Residential Building with 7 dwelling units at Old No.100, New No.27, South Street, O.S.154/1, T.S.No.62, Block No.36, Ayanavaram Division, Chennai, has been approved subject to the conditions incorporated in the reference 4th cited.

- 2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 5th cited and has remitted the necessary charges in Challan No. 3395 dt. 2.5.05 including Development charges for land and Building Rs.12,000/- (Rupees TwelveThousand only) Scrutiny Fee of Rs.200/- (Rupees Two hundred only) Security Deposit for building Rs. 36,000/- (Rupees Thirty six thousand only) and Display Deposit of Rs.10,000/- (Rupees Ten thousand only).
- 3) (a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 45,700/- (Rupees Forty five thousand and seven hundred only) towards water supply and sewerage infrastructure improvement charges in his letter dt. 4.5.2005.
- (b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

- water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically scaled of with properly protected vents to avoid mosquito menace.
- 4) Non-Provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.
- 5) Two sets of approved plans numbered as Planning Permit No. B / Spl.Bldg. / 177 / 2005 dt. 3/06 /2005 are sent herewith. The Planning Permit is valid for the period from 3/06 / 2005 to 2/06 / 2008.
- 6) This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only, after which the proposed construction can be commenced.
