- 2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4th cited and has remitted the necessary charges in Cash Bill No.B-36308 dated 23.9.04 including Security Deposit for building Rs.42,000/- (Rupees forty two thousand only), DD of Rs.10,000/- (Rupees Ten thousand only) in Cash.
