- 2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 9th cited and has remitted the necessary charges in Cash Bill No. C-2133.dt. 15.3.05 including Security Deposit for building Rs. 39,500/- (Rupees Thirty nine thousand and five hundred only) and Display Deposit of Rs.10,000/- (Rupees Ten thousand only) in Cash.
- (a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 48,000/- (Rupees Forty eight thousand only) towards water supply and sewerage infrastructure improvement charges in his letter dt. 16.3.05.
