Sub:-CMDA - Area Plans Unit - Planning Permission - Proposed construction of Stilt + 4 Floors Residential Building with 4 dwelling units at Plot No.2, New Door No. 138, 138-A Nelson Manickam Road, T.S.No.1, Block No.12 (R.S.No.6, 8/1,2) of Vada Agaram Village, Aminjikarai, Chennai - Approved - Reg.

The Planning Permission Application and Revised Plan received in the reference Ist cited for the construction of Stilt + 4 Floors Residential Building with 4 dwelling units at Plot No.2, New Door No. 138, 138-A Nelson Manickam Road, T.S.No.1, Block No.12 (R.S.No.6, 8/1,2) of Vada Agaram Village, Aminjikarai, Chennai, has been approved subject to the conditions incorporated in the reference.

2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference cited and has remitted the necessary charges in Cash Bill No. 37427 dated 19.10.04 including Security Deposit for building Rs.45,000/- (Rupees Forty five thousand only), and Security Deposit for Display Board Rs.10,000/- (Rupees Ten thousand only) in Cash.

3) a. The applicant has furnished a demand draft in favour of Managing Director, CMWSSB, for a sum of Rs. 56,000/- (Rupees Fifty six thousand only) towards Water Supply and Sewerage Infrastructure Improvement Charges in his letter.

b. With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he / she can commence the internal sewer works.

c. In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the Promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.

4) Non Provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two sets of approved plans numbered as Planning Permit No. B / Spl.Bldg. / 523 / 2004 dated 28.10.2004 are sent herewith. The Planning Permit is valid for the period from 28.10.2004 to 27.10.2007.

6) This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
