To process the application further, you are requested to remit the following by separate Demand Drafts of a Nationalised Bank in Chennai City drawn in favour of Member-Secretary, CMDA, Chennai -8 or in cash at cash counter (between 10.00 A.M. and 4.00PM) in CMDA and produce the duplicate receipt to the Area Plans Unit 'C' Channel Division in CMDA.

- i) Development charge for land and building under Sec.59 of Town and Country Planning Act, 1971.
- : Rs. 1,01,000/- (Rupees one Lakh and one thousand only)
- ii) Additional Scrutiny fee : Rs. 2,000/- (Rupees Two thousand only)
- iii) Regularisation charge : Rs. 1,33,000/- (Rupees one Lakh and thirty three thousand only)



- iv) Open space Reservation charges : Rs. (i.e. equivalent land cost in lieu of the space to be reserved and handed over as per DCR 19a(iii)
  - : Rs. v) Security Deposit (for the proposed development)

(Security Deposit is refundable amount without interest on claim, after issue of Completion Certificate by CMDA. If there is any deviation/viol/tion/change of use of any part or whole of the building/site to the approved plan, Security Deposit will be forfeited and action will be taken).

- 2. In the event of the Security Deposit is not claimed within a period of 5 years from the date of remittance, the Security Deposit shall be forfeited without any future notice.
