4. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.

5. You are also requested to comply the following:

- a) Rain water conservation measures notified by CMDA should be adhered to strictly.
- b) Revised plans satisfying Front set back and Lorry parking requirements**
- c) Terrace floor plan is wrongly mentioned as first floor plan in the detailed plan**

6. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
