ii) In case of Multi-storeyed Building both qualified Architect and qualified Structural Engineer who should be a Class-I Licensed Surveyor shall be associated and the above information to be furnished. iii) A report to writing shall be gent to Chennai Metropolitan Development Authority by the Architect/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan, similar report shall be sent to CMDA when the building has reached upto plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is corried

out in deviation to the approved plan.

iv) The owner shall inform Chennai Metropolitan Development Authority of any change of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CliDA that he has agreed for supervision the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between exit of the previous Architect/Licensed Surveyor and entry of the new appointee.

v) On completion of the construction the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CHDA.

vi) While the applicant makes application for service connection such as Electricity, Water Supply, Severage he should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department/Board/Agency.

vii) When the site under reference is transferred by way of sole/ lease or any other means to any person before completion of the construction, the party shall inform CHDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to those conditions to the planning permission.

viii) In the open space within the site, trees should be planted and the existing trees preserved to the extent possible;

ix) If there is any false statement, suppression or any misrepresentations of acts in the applicant, Planning Pormission will be liable for cancellation and the development made, if any will be treated as unauthorised.

x) The new building should have mosquito proof over head tanks and wells.

- xi) The sanction will be void admitted, if the conditions mentioned above are not complied with.
 xii) Rain Water conservation measures notified by CMDA should be adhered to strictly.
 xii) a. Undertaking (in the format prescribed in Annexure-XIV to DCR, a copy of it enclosed) in Ps.10/- stamp paper duly executed by all the land owner, GPA holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.
 - b. Details of the proposed development duly filled in the format enclosed for display at the site. Display of the information at site is compulsory in cases of hulti-storeyed Buildings, Special Buildings and Group Developments.

The acceptance of the Authority of the pre-payment of the Development charge and other charges etc., shall not entitle the person to the planning permission but only refund of the development charge and other charges (excluding Scrutiny Fee) in cases of refusal of the permission for non-compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission or any other reason provided the construction is not commenced and claim for refund is made by the applicant.
