2. The applicant has remitted the following charges:

3. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Non provision of Rain water harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of DCR and enforcement action will be taken against such development.

5. Two copies of approved plans, numbered as Planning permit No.C/953/44/2004 A to C/2004, dated 4-8-2004 is sent herewith. The planning permit is valid for the period from 4-8-2004 to 3-8-2007.

6. This approval is not final. The applicant has to approach the ~~Chennai~~ Panchayat Union for issue of building permit under the Local Body Acts, only after which the proposed construction can be commenced.
