The Planning Permission Application received in the reference cited for the construction of Stilt part + Ground Floor part + First Floor + Second Floor part of residential building with 4 dwelling units at Plot No.4B, D.No.36, N.No.87, Basha Street, Choolaimedu, Chennai - 94 in T.S.No.140/11 (part), Block No.15 of Puliyur village was examined and found approvable, as per the plans submitted by the applicant directly to this office.

- iv) 'Non provision of Rain Water Harvest structures as shown in the approved plan to the satisfaction of the Authority will also be considered as a deviation to the approved plan and violation of DCR and Enforcement action will be taken against such development.
