CMDA.

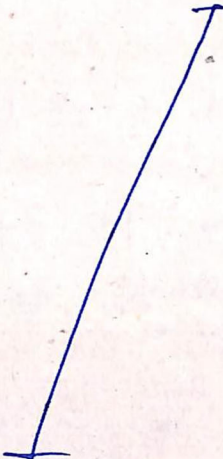
- i) Development charges for land and building : Rs. 6,000/- (Rs Six Thousand only)
