CMDA.

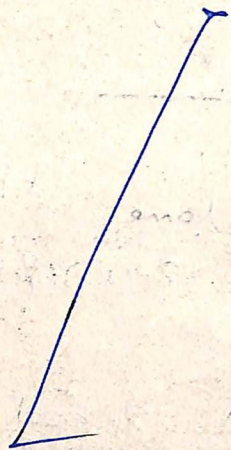
- i) Development charges for land and building : Rs. 2,000/- (Rs. Two Thousand only)

But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
