2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.



- b. Five copies of revised plan showing the 3 car parking requirements.


5. The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
