CMDA.

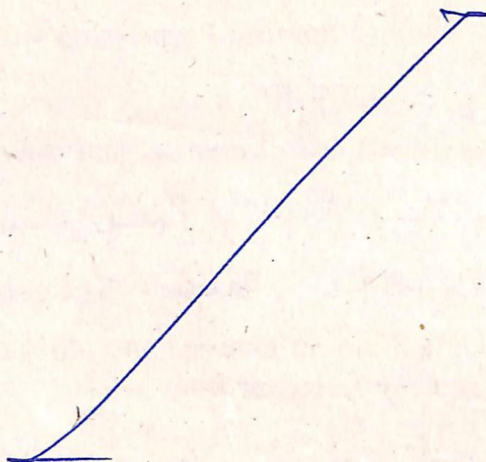
