Sir/Madam,

Sub: CMDA - Planning Permission - Construction of Ground Floor Residential Building at P.No.74, Chandrasekar Nagar, Okkiam Thoraipakkam village, Chennai in S.No.259/1A3 of O. Thoraipakkam village - Development charges and other charges to be remitted - Reg.

Ref: Lr.No.L.Dis.7549/2004/A4 dt. 30.12.04 from the Commissioner, St. Thomas Mount P.U.

The Planning Permission Application received in the reference cited for the construction of Ground Floor residential building at Plot No.74, Chandrasekar Nagar, Okkiam Thoraipakkam village, Chennai in S.No.259/1A3 of Okkiam Thoraipakkam village was examined and found approvable.

To process the application further, you are requested to remit the following charges by **three** separate Demand Draft/s of a Schedule/Nationalised Bank in Chennai City drawn in favour of 'THE MEMBER-SECRETARY, CMDA, CHENNAI-8' at cash counter (between 10.00 AM and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, CMDA.

- i) Development charges for land and building : Rs. 1,900/- (Rs. one thousand and nine hundred only)
- ii) Scrutiny Fee : Rs. --
- iii) Regularisation charges : Rs. 1,950/- (Rs. one thousand nine hundred & fifty only)
- iv) Open Space and Reservation charges : Rs. 65,500/- (Rs. sixtyfive thousand & five hundred only)

2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

4. You are also requested to comply with the following:

a. Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.

b. 5 copies of revised plan indicating the set back at crucial points to be shown.

5. The issue of planning permission will depend on the compliance/fulfillment of the conditions/payments stated above.
