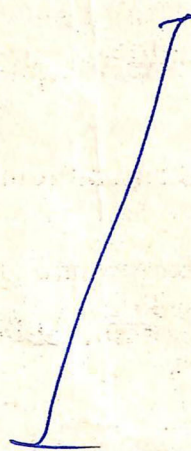
- i) Development charges for land and building : Rs. 1,400/- (Rs one thousand and four hundred only)
