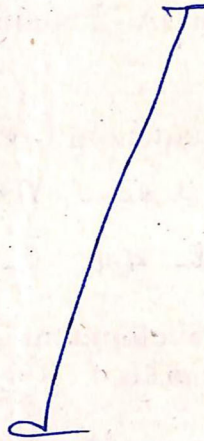
- i) Development charges for land and building : Rs. 5,250/- (Rs five thousand and two hundred and fifty only)
