CMDA.

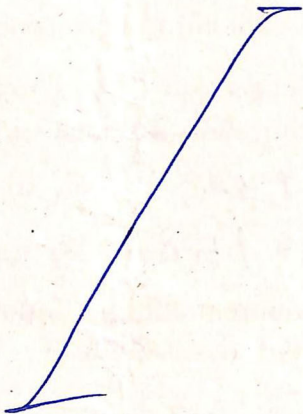
