
- i) Development charges for land and building : Rs. 5,900/- (Rs five thousand and nine hundred only)
 - ii) Scrutiny Fee : Rs. 500/- (Rs five hundred only)
 - iii) Regularisation charges : Rs. 6,500/- (Rs six thousand and five hundred only)
 - iv) Open Space and Reservation charges : Rs. 1,62,700/- (Rs one lakh and sixty two thousand and seven hundred only)

2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered.
