The planning permission application received in the references... *and the revised plans* cited for the *proposed* construction of *skit parking* floor + 4 floors residential building with 12 dwelling units at Dno: 12, East Circular road, Mandavelipattanam, R.No: 4483/11, Block no: 99 of Mylapore, Chennai

Chennai, has been approved subject to the conditions incorporated in the reference... *C.D.A.* cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference... *A.D.A.* cited and has remitted the necessary charges in Challan No. C 12294 dated 19.5.06 including Development Charges for land and building Rs. 20,000/- (Rupees *Twenty thousand only*) Regularisation Charges Rs. \_\_\_\_\_ (Rupees \_\_\_\_\_) Open Space Reservation charges Rs. \_\_\_\_\_ ( \_\_\_\_\_ ) Security Deposit for building Rs. 82,000/- (Rupees *Eighty two thousand only*) \_\_\_\_\_ ) and Display Deposit of Rs. 10,000/- (Rupees Ten thousand only) and ~~SD for Septic Tank~~ Rs. \_\_\_\_\_ ( \_\_\_\_\_ ) in cash.

3.a) The applicant has furnished a Demand Draft in favour of M.D, CMWSSB for a sum of Rs. 1,02,400/- (Rupees one lakh two thousands and forty) towards water supply and sewerage infrastructure improvement charges in his letter dated 19.5.2006.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sum for the above premises for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.

4) Non-provision of Rain water Harvest structure as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as planning permit No. B /Spl.Bldg/ 255 /2006, dated 26.05.2006 are sent herewith. The planning permit is valid for the period from 26.05.2006 to 25.05.2009.

6) This approval is not final. The applicant has to approach the Corporation of Chennai for issue of building permit under the Local Body, Act, only after which the proposed construction can be commenced.

7) The Local Body is requested to monitor the buildings and ensure that the constructions are made as per the approved plan and also to initiate enforcement action then and there if the buildings are constructed in deviation to the approved plan.
