The Planning Permission Application and Revised Plan received in the reference 1st & 2nd cited for the proposed construction of Stilt + 4Floor (8 dwelling units) residential building at Plot No.C-16, New Door No.14, Old Door No.11, 5th Main Road, Nanganallur, Chennai-61, S.No.39/2, T.S.No.2, Block No.19, Nanganallur, Chennai has been approved subject to the conditions incorporated in the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4th cited and has remitted the necessary charges in Challan No.C 8835 dated 26.12.2005 including security deposit for building Rs.51,000/- (Rupees fifty one thousand only) and DD for Display Board of Rs.10,000/- (Rupees ten thousand only) in cash.

3. The Local Body is requested to ensure water supply and sewerage disposal facility for the proposal before issuing building permit.

4. Non provision of Rain Water Harvest structures as shown in the approved plan to the satisfaction of the authority will also be considered as a deviation to the approved plans and violation of development Control Rules and enforcement action will be taken against such development.

5. Two sets of approved plans numbered as Planning permit No.B/Special Building/447/2005, dated 29.12.2005 are sent herewith. The planning Permit is valid for the period from 29.12.2005 to 26.12.2006.

6. This approval is not final. The applicant has to approach the Municipality for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.

7. The Local Body is requested to monitor the buildings and ensure that the constructions are made as per the approved plan and also to initiate enforcement action then and there if the buildings are constructed in deviation to the approved plan.
