The Planning Permission Application ^{and the revised plans} received in the reference... 1st R. Reg cited for the construction of *with parking* floor + 4 floors residential building with 5 dwelling units at D.No: 52/4 and 53/2, 1st main road, C.I.T. colony, Old R.No: 1607, Present R.No: 1595/182, 1595/189. Block no: 33 of Mylapore village, Chennai -
Chennai, has been approved subject to the conditions incorporated in the reference ... 4.11 cited.

2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4.11 cited and has remitted the necessary charges in Challan No. 6060 dated 12.8.2005 including Development Charges for land and building Rs. 14,000/- (Rupees *fourteen thousands only*), Regularisation Charges Rs. 11,000/- (Rupees *eleven thousands only*), Open Space Reservation Charges Rs. _____ (Rupees _____) Security Deposit for building Rs. 57,000/- (Rupees *fifty seven thousands* only) and Display Deposit of Rs. 10,000/- (Rupees Ten thousand only) and SD for septic Tank Rs. _____ (Rupees _____) in Cash.

3) (a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 70,400/- (Rupees *seventy thousands and four hundred* only) towards water supply and sewerage infrastructure improvement charges in his letter dt. 12.8.2005.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mosquito menace.

4) Non-Provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as Planning Permit No. B / Spl.Bldg. / 307 / 2005 dated 12.08.2005 are sent herewith. The Planning Permit is valid for the period from 12.08.2005 to 16.08.2008.

6) This approval is not final. The applicant has to approach the ^{Copy of demand} Township for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
