The planning permission application and revised plan  
received in the reference 1st and 2nd cited for the construction  
of Group Development Stilt + 4th floors Block A1, A2, A3, A4,  
A5, A6 and A7 and Block-C Ground + IIInd floors with 117 dwelling  
units with Club House in Block-C (Ground floor part) at Plot No.1,  
Green Acres Road, S.No.185/9 part, 10 part, 11 part, 173/4 part,  
5 part, 6 part, 7A, 7B, 7C and 7D of Perungudi village, Tanbaran  
Taluk, Kancheepuram District, Chennai-96 has been approved  
subject to the conditions incorporated in the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4th cited and has remitted the necessary charges in Challan No.C.9392, dt.30.01.2006 for Development charges Rs.2,65,000/- (Rupees two lakhs and sixty five thousand only), Security Deposit for the proposed development Rs.10,65,000/- (Rupees ten lakhs and sixty five thousand only), Security Deposit for septic tank with upflow filter Rs.1,23,000/- (Rupees one lakh and twenty three thousand only) and Security Deposit Rs.10,000/- (Rupees ten thousand only) for Display Board in cash.

3. The Local Body is requested to ensure water supply and sewerage disposal facility for the proposal before issuing building permit.

4. The Up Flow Filter to be initially maintained by the promoter till the Residents' Association is formed and take over it.

5. Non provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority and also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

6. Two sets of approved plans numbered as Planning Permit No.B/Spl.Bldg./38A to J/2006, dt.02.02.2006 are sent herewith. The Planning Permit is valid for the period from 02.02.2006 to 01.02.2009.

7. This approval is not final. The applicant has to approach the Perungudi Special Panchayat for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.

8. The Local Body is requested to monitor the buildings and ensure that the constructions are made as per approved plan and also to initiate enforcement action then and there if the buildings are constructed in deviation to the approved plan.

9. The applicant has also executed notarised deed of undertaking dt.29.12.2005 stating that the flats constructed as per planning permission issued by CMDA will not handed over to the prospective purchasers for occupation unless and until the Sewerage Treatment Plant facility is executed and commissioned as per Chennai Metropolitan Water Supply and Sewerage Board concurrence, failing which CMDA may take necessary action to revoke the planning permission for the proposed development.
