No. 21, and 21B, New Door No. 81, Medavakkam Main Road, Venkateswara
Nagar in S.No. 258/1c1B of Madipakkam -II (Keelkattalai village,
Chennai has been approved subject to the condition incorporated in
the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated
by Chennai Metropolitan Development Authority vide in the reference
4th cited and has remitted the necessary charges in Challan No.
C-6183 dated 19.8.2005 including security Deposit for building
Rs. 50,000/- (Rupees fifty thousand only) and BB-of-Rs.-10,000/-
(Rupees-ten-thousand-only) Display Board of Rs. 10,000/- (Rupees
ten thousand only) in cash and septic tank with upflow filter
of Rs. 13,000/- (Rupees thirteen thousand only)

3. The Local Body is requested to ensure water supply
and sewerage disposal facility for the proposal before issuing
building permit.

4. Non provision of rain water harvest structures as
shown in the approved plans to the satisfaction of the Authority
will be also be considered as a deviation to the approved plans
and violation of Development Control Rules and enforcement
action will be taken against such development.

5. Two sets of approved plans numbered as planning
permit No. B/Spl.Bldg/311-A and B/2005, dated 25.8.2005 are
sent herewith. The planning permit is valid for the period
from 25.8.2005 to 24.8.2005.

6) This approval is not final. The applicant has to approach the M.L.Panchayat Union for issue of building permit under the local body act, only after which the proposed construction can be commenced.
