*for the planning permission application received in
the reference 1st cited for the construction of Ground floor
+ 3floors residential building with 7 dwelling units at Old
No.35, New No.97, Siruvallur Main Road in R.S.No.52/2
T.S.No.49, Block No.16, Siruvallur village, Chennai hasbeen
approved subject to the conditions incorporated in the
reference 5th cited and also subject to the conditions
imposed by Southern Railway in the reference 4th cited.*

2. The applicant has accepted to the conditions
stipulated by CMDA vide in the reference 6th cited and has
remitted the necessary charges in Challan No. C9146, dt.
12.1.06 including Development charges for land and building
Rs. 9,700/- (Rupees Nine thousand and seven hundred only)
Security Deposit for building Rs. 31,000/- (Rupees Thirty one
thousand only) and Display Depesit of Rs. 10,000/- (Rupees
Ten thousand only) in cash.

3. a) The applicant has furnished a Demand Draft
in favour of Managing Director, CMWSSB for a sum of Rs.39,100/-
(Rupees Thirty nine thousand and one hundred only) towards
water supply and sewerage infrastrucure improvement charges
in his letter dated 12.01.06.

b) With reference to the sewerage system the
promoter has to submit the necessary sanitary application
directly to Metro water and only after due sanction he/she
can commence the internal sewer works.

c) In respect of water supply, it may be possible
for Metro water to extend water supply to a single sump for the
above premises for the purpose of drinking and cooking only
and confined 5 persons per dwelling at the rate of 40 lpcd.

In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed for with properly protected vents to avoid mesquite menace.

4. Non provision of rain water harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5. Two copies of approved plans numbered as Planning Permit No. B/Spl. Bldg/15/2006, dated 18.1.2006 are sent herewith. The planning permit is valid for the period from 18.01.2006 to 17.01.2009.

6. This approval is not final. The applicant has to approach the Township for issue of building permit under the local body act, only after which, the proposed construction can be commenced.
