The Planning Permission Application received in the reference.....1st cited for the construction of additional construction of G/F+2 floors of 6 blocks with 108 tenements to the existing G/F+2 floors of 18 blocks with 324 tenements (Total 24 blocks with 432 tenements) at S.No. 1844/2 pt, Block No: 31 or Tundianpet village, Bhavathinagar -

Chennai, has been approved subject to the conditions incorporated in the reference ..2nd cited and also subject to the condition that the off area and roads like handed over to the local body within 3 months of the completion of the project

2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference ..B.M dated 29-3-05 and has remitted the necessary charges in Challan No...24123 dated 29-3-05 including Development Infrastructure building Rs....1,61,000/- (Rupees One Lakh Sixty Thousand only) and Display Deposit of Rs.10,000/- (Rupees Ten thousand only) in Cash. Balance sum of Rs 13,700/- (Rupees Thirteen Thousand and Seven hundred only)

3) (a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs..1,47,190/- (Rupees one lakh forty seven thousand and one hundred only) towards water supply and sewerage infrastructure improvement charges in his letter dt. 15-4-05.

b) In reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 15 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal. Appropriate works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed or with properly protected vents to avoid mosquito menace.

4) Non-Provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority, will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as Planning Permit No. B / Spl.Bdg./125A2B.bwpt 200 dated 28-4-05 are sent herewith. The Planning Permit is valid for the period from 28.4.05 to 27.04.08.

6) This approval is not final. The applicant has to approach the Township for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
