The Planning Permission Application received in the reference I. S. I. dt. 07-06-05 cited for the construction of silt pond + AP pond + GF + 3 FL. part of Residential Building with 36 dwelling units at New D. No 12, Old. S. No 137, Perambur High Road, In R.S. No 257, BK- 15 part of perambur village;

Chennai, has been approved subject to the conditions incorporated in the reference II. cited.

2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 11/05 cited and has remitted the necessary charges in Challan No. 38015, dated 9-11-04, including Security Deposit for building Rs. 132,000/- (Rupees one lakh Thirty Two Thousand) and Display Deposit of Rs. 10,000/- (Rupees Ten thousand only) in Cash. D.C. Accts Rs 36,000 (THIRTY SIX THOUSAND ONLY) paid in earlier P.P. issued file No B3/17923/04 DT 25-11-04 and Gentry Acct of Rs. 600 (Rupees Six hundred only) vide chn 3472 D.T 5-5-05.

3) (a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for sum of Rs. 1,681,200/- (Rupees ONE LAKH SIXTY EIGHT THOUSAND AND only) towards water supply and sewerage infrastructure improvement charges in his letter dt. 5-5-05. It remitted in earlier P.P. issued file No B3/17923/04 dt. 25-11-04.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single supply for the above premises for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 10 l/pqd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water authority. It shall be ensured that all wells, overhead tanks and septic tanks are hygienically sealed of with properly protected vents to avoid mosquito menace.

4) Non-Provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as Planning Permit No. B / Spl.Bldg. / 217 A&B/2005 dated 01/05/05 are sent herewith. The Planning Permit is valid for the period from 01/05/05 to 20/06/08.

6) This approval is not final. The applicant has to approach the Township for issue of building permit under the Local Body Act, only after which the proposed construction can be done.
