The Planning Permission Application received in the reference. 1 st cited for the construction of Stilf floor + 4 floors Residential luilding with & Dwelling units at pose plot no w-109, park food, first street, Anna Nagar west Extension, Sno 120 part of padi Willage. Chemai

Chennai, has been approved subject to the conditions incorporated in the reference .4.15 cited.

2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference A.L. cited and has remitted the necessary charges in Challan No. 4.7.4.6. dated ...4.107105 including Development Charges for land and building Rs. 11,000/= (Rupees Elevent thousand only), Regularisation Charges Rs. 1,800/= (Rupees one thousand,), Open Space Reservation Charges Rs. (Rupees Security Deposit for building Rs. 45,000/- (Rupees Forty the thousand only) and Display Deposit of Rs. 10,000/- (Rupees Ten thousand only) and SD for septic Tank Rs. (Rupees)in Cash.

3) (a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 55.400/=/ (Rupees Fifty fire Rouland Roundsedonly) towards water supply and sewerage infrastructure improvement charges in his letter at. 18.-07-2005.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

- c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.
- 4) Non-Provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.
- 6) This approval is not final. The applicant has to approach the Township for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
